This is a sanctioning agreement between Performance Open Wheel Racing Incorporated (POWRi) and the undersigned racetrack owner/operator (Promoter). Neither POWRi nor the Promoter has any authority to assume or create any obligation or liability, either express or implied, on behalf of the other.

**Annual Requirements:** This sanctioning agreement entitles the Promoter to hold events for sanctioned POWRi Divisions on the designated Race Night at the Track. The promoter must furnish a season schedule designating which dates and divisions will be sanctioned by POWRi. Unless notified otherwise by the Promoter, all approved events will award POWRi National Points. There is no charge for POWRi StockMod track sanctioning, facilities are responsible for the collection and payment to POWRi of Membership and Temporary Permit license fees.

**Licenses:** All competitors in sanctioned events must possess a POWRi License. The cost of a POWRi StockMod Competitor License is \$100 for the Super Stock, B-Mod, and Midwest Mod divisions. Temporary Permit licenses are available for \$20 per driver for each division per event entered; TP license entrants do not receive National Points nor combine to equal membership.

**Rules:** Sanctioned tracks must adhere to all POWRi StockMod divisional rules for any sanctioned classes. Compliance with these rules is mandatory to ensure fair competition and consistency across all events. Failure to follow the POWRi StockMod rules may result in penalties, including disqualification of races, suspension of track sanctioning, and other disciplinary actions as deemed appropriate by the POWRi governing body. Track operators and participants are responsible for familiarizing themselves with and upholding all current divisional rules to maintain their sanctioned status.

### Technical Inspectors

To ensure fair competition and maintain safety standards, all POWRi-sanctioned tracks must have a designated Tech Official. The Tech Official is responsible for enforcing technical rules, inspecting cars, and verifying compliance with POWRi regulations.

**POWRi StockMod Nationals:** During the POWRi StockMod Nationals (September 24-26), National points for all divisions will be awarded at the POWRi StockMod Nationals only. Dates are subject to change.

**Name of Track Insurance Company:** \_\_\_\_\_

Prior to the first sanctioned event, the Promoter must furnish POWRi a copy of the track liability insurance policy which contains the minimum specified coverage as follows: Liability insurance arising out of or as a result of a racing event, including all costs and expenses, including attorney's fees incurred in the defense thereof, and such insurance shall include a minimum per occurrence and combined single limit of liability of one million dollars(\$1,000,000) for spectator bodily injury and property damage. The policy must also include the following coverage: participant legal liability, premises, premises medical payment, malpractice, food and beverage, mobile equipment, products/completed operations, personal injury, advertising injury, and contractual liability. However, nothing herein shall require the promoter's liability policy to insure a participant-to-participant claim. Additional proof of participant accident coverage must be shown on the certificate of insurance showing a minimum of five thousand dollars(\$5,000) for accidental death and dismemberment and five thousand dollars(\$5,000) medical coverage for all participants of the event. POWRi must be listed as additional insured parties in the document. Before the first sanctioned event, the Promoter shall also furnish a true copy of the certificate of insurance showing the above minimum insurance limits naming POWRi and their directors, officials, official representatives, employees, and executive officers as additional insured.

Failure to comply with this Agreement may result in the revocation of sanctioning and license to use the POWRi logo, name, and other copyrighted and trademarked works. The undersigned have read the above Agreement and agree to be bound by its terms and conditions.
